Eligibility Terms: Essays are welcome from representatives of all PacPay-WACHA members. Applicants must submit an essay to WACHA via fax or mail by April 15th explaining how you will use this information to further your career in the payments industry. Each applicant must receive signed approval from a senior officer at their organization stating that the applicant is permitted to attend TPI and, if they should win, to accept the scholarship. Scholarship recipients will reside in accommodations provided by TPI and, therefore, cannot be accompanied by a spouse or dependents. Other accommodations are available at the applicant's expense. Following their attendance at TPI, the winning applicant will also be required to submit to WACHA an essay summarizing their experiences at TPI for inclusion in an upcoming issue of this e-newsletter.
